## **INTRODUCTION**

Till now, around 3000 trees, 6500 Shrubs and 12000 sqm of grass have been planted in IIM Tiruchirappalli (IIMT) Campus. It is also proposed to plant the saplings on road sides to develop the greenery in the campus. To water the plants efficiently, it is proposed to lay the drip irrigation pipeline in the campus for about 60 acres area (for existing trees and future plantation) and the 60 acres are not located in one place and is spread across 175 acres. The total area of the campus is about 173.87 Acres. It is about 18 kms from Railway Station and 8 kms to Airport. The land is generally even and level.

Based on the previous experience, the top 3 (three) vendors would be invited for site visit.

The **Design Brief** will contain the site plan, specifications, Bill of Quantities (BoQ), detailed scope of work, as per our requirements. The contractor requested to make site visit to understand the requirement, before the pre-bid meeting. **A Pre-Design Brief meeting** will be conducted on 25/05/2020, Monday at 11.00 hrs in the Dean's Office Meeting Room, Indian Institute of Management Tiruchirappalli to clarify doubts that may arise before submission of the design brief. The pre-design brief meeting may either be conducted physically or through online mode, which will be intimated in the Institute website

All the participants would be given an opportunity to present in person and explain their design to the Competent Evaluation Committee to be constituted by Institute. Marks will be awarded based on this technical evaluation of entries.
