Instructions for Online Bid Submission

The bidders are required to submit soft copies of their bid electronically on the e-Wizard Portal using valid Digital Signature Certificates. Below mentioned instructions are meant to guide the bidders for registration on the e-Wizard Portal, prepare their bids in accordance with the requirements and submit their bids online on the e-Wizard Portal. For more information, bidders may visit the Portal (<https://mhrd.euniwizarde.com/>)

1. Registration Process on Online Portal

- a. Bidders to enroll on the e-Procurement module of the portal <https://mhrd.euniwizarde.com/> by clicking on the link “Bidder Enrolment”.
- b. The bidders to choose a unique username and assign a password for their accounts.
- c. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. This would be used for any communication from the e-Wizard Portal.
- d. Bidders to register upon enrolment, with their valid Digital Signature Certificate (Class III Certificates with signing and Encryption key) issued by any Certifying Authority recognized by CCA India with their profile.
- e. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- f. Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token

2. Tender Documents Search

- a. Various built-in options are available in the e-Wizard Portal like Department name, Tender category, estimated value, Date, other keywords, etc. to search for a tender published on the Online Portal.
- b. Once the bidders have selected the tenders they are interested in; they may download the required documents/tender schedules. These tenders can be moved to the respective ‘Interested tenders’ folder.

- b. The Institute may at its own discretion extend the last date for the receipt of bids.
- c. IIM Tiruchirappalli reserves the right to cancel the tender without assigning any reason at any stages of evaluation before finalization.
- d. IIM Tiruchirappalli also reserves the right to, at any time and in its absolute discretion the following:
 - Accept or reject all bids.

NOTICE INVITING TENDER

1. OVER VIEW

Indian Institute of Management Tiruchirappalli (IIM Tiruchirappalli) is an Institute of National Importance, established by the Ministry of Education (Shiksha Mantralaya), Government of India, is the eleventh IIM and was instituted on 4th January 2011. More details about IIM TIRUCHIRAPPALLI are available in our website www.iimtrichy.ac.in.

IIM TIRUCHIRAPPALLI invites e-Tender for *Supply/Renewal Business/professional/corporate edition antivirus application for desktops and servers along with support and updates for a period of 3 years to IIM Tiruchirappalli.*

2. PERIOD OF CONTRACT

Initially the Contract for the Period of **Three years**. However, Institute reserves the right to extend the contract period for **2 more year** based on the rates quoted by the bidder in Additional Items of the Price Bid.

If institute decides to procure the Additional items, it will be done during the expiry of the mandatory items as per the rate given in this tender. All the terms and conditions given in this tender would be applicable for the optional items as well.

3. BID PREPARATION

- Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid.
- Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that needs to be submitted. Any deviations from these may lead to rejection of the bid.
- Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/XLSX/PNG, etc. formats.

4. PROCEDURE FOR SUBMISSION OF TENDER

- Bidder to log into the site well in advance for bid submission so that he/she uploads the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.

- b. The tender document should be downloaded from the IIM Tiruchirappalli website <https://www.iimtrichy.ac.in/tender-published> and e-Wizard Portal <https://mhrd.euniwizarde.com/>
- c. The bidder(s) shall not make any changes or amendment in the tender document as published in the IIM Tiruchirappalli website and MHRD e-Wizard Portal.
- d. All the pages of the tender document being submitted must be duly (Digitally) signed as per the procedures and requirements stipulated herein.
- e. The tender document should be filled in legible handwriting/printing/typing without any ambiguity.
- f. If any correction is necessary in the information provided by the bidder, the same should be made after scoring out the old entry. In any case, there should not be any over writing. All the corrections should be attested with full signature of the bidder with date.
- g. Bidder should take into account the corrigendum/Addendum published from time to time before submitting the bids.
- h. The bidders are cautioned that furnishing of incomplete/ambiguous information, suppression of facts and any alteration of the prescribed tender format will entail outright rejection of the bid application.

5. BASIC ELIGIBILITY CONDITIONS FOR THE BIDDERS

- a. The bidder(s) should be registered with the Goods and Services Tax council for the purpose of Goods & Service Tax (GST). A copy of GST Registration Certificate, PAN and Bank account details should be submitted along with the Tender document. The names appearing on all these documents and tender document should be same or linked.
- b. Manufacturer's Authorization Letter (MAF) from the OEM clearly indicating that the bidder is competent to sell & provide the required services for the items. Bidder should submit Manufacturer's Authorization Letter (MAF) along with the tender document, failing which the tender will not be considered.
- c. It is construed that the bidder has read all the terms and conditions before submitting their offer. The bid declaration as given in the [Annexure-IV](#) to the effect of stating that the terms and conditions of the tender have been read and abided by the tenderer shall be furnished.
- d. The bidders should not be blacklisted by any department of the Government of India or any State Government and Private organization in the past. There should not be any criminal case registered against the bidding firm or its owners/partners anywhere in India. An undertaking to this effect in the Company letter head duly signed by the owner / partner or both to be enclosed, as per [Annexure-V](#).

6. Acceptable Makes

7. EARNEST MONEY DEPOSIT

- a. The bidder(s) should remit an Earnest Money Deposit (EMD) of Rs. 40,300/- (Rupees Forty Thousand and Three Thousand only) at MoE's e-Wizard Portal. A copy of the payment transaction receipt has to be attached with the e-Tender application form, without which the tender won't be considered for the bidding process.
- b. The EMD of the successful bidder will be converted into interest free security deposit.
- c. The EMD of the unsuccessful bidders will be released after the finalization of the tender. No interest is payable on the Earnest Money Deposit (EMD).
- d. Micro and Small Enterprises (MSEs) firms as defined in the MSE Procurement Policy issued by the Department of Micro, Small and Medium Enterprises (MSME) or the firms registered with the Central Purchase Organization or the concerned Ministry or Department or Startups as recognized by Department of Industrial Policy & Promotion (DIPP) for all these items only, are exempted from EMD. However, they have to enclose valid self-attested registration certificate(s) along with the tender to this effect.
- e. The bidders who seek exemption from EMD as per the clause above, if they withdraw or modify their bids during the period of validity, or if they are awarded the contract, and they fail to sign the contract or to submit performance security before the deadline defined in the bid document, they will be suspended for the period of three years or as decided by the competent authority from being eligible to submit bids for contracts with the entity that invited the bids.

8. BIDS CRITERIA

- i. The bidder should quote for Only one make from the above acceptable makes for all the Version of Antivirus mentioned in [Annexure-III](#) of The Technical Specification Section. The specification of the product should match/comply 100% with the tender specification. Technical compliance sheet should be enclosed.
- ii. The bidders should not quote for multiple brands in a single bid.
- iii. The bidder should quote only for enterprise/professional/business/corporate edition/version Antivirus software.

- iv. Support and upgrades for all the existing features and licenses needs to be provided for the three years' period.
- v. The Rates quoted by the tenderer should be inclusive of all but **except GST** and must hold good till the completion of work and shall not be subjected to any escalation. No claim on this account what so ever shall be entertained at any stage including the extended period, if any.
- vi. Tender must be submitted with the rates for all the items (**including Mandatory and Additional items**) mentioned in the Price Bid and any incomplete tender will not be considered.
- vii. **The cost given for Additional items will not be considered for selecting L1. The work order will be awarded to L1 based on the cost quoted for the mandatory items.**
- viii. **Price Bid** (BoQ) given in tender to be submitted after filling all relevant information and it should be submitted **only for the brand and specifications mentioned in the price Bid (Annexure-II)**. The priced BoQ should be submitted strictly as per the Price Bid (BoQ), failing which the offer will be rejected and renaming or changing the format of BoQ will not be acceptable. The Bidder should quote the price inclusive of all charges but **exclusive of GST**.
- ix. Arithmetical errors, if any, shall be rectified on the following basis. If there is a discrepancy between the unit price and total price, then the unit price shall prevail and the total price shall be corrected by the Institute. If the Bidder does not accept the correction of the errors, the bid shall be rejected. All Rates, Prices, Amounts and Sums quoted by the bidder shall be in Indian currency only. The language used throughout shall be English.

9. SUBMISSION OF BIDS

The Online bids (complete in all respect) must be uploaded online in single cover as explained below:

- iv. Copy of PAN and GST Registration.
- v. MAF Certificate from OEM
- vi. Duly (Digitally) Signed Tender document and it's all annexures.
- vii. **Annexure-II of Price bid** –BoQ in MS Excel “.xls” format should be uploaded in the same cover.

10. PRE-BID CLARIFICATION

The Answers / clarifications will be communicated to the bidder after pre bid clarification deadline (i.e 3.00 pm, 02.01.2023).

11. OPENING OF BID

The tenders received from all the bidders will be opened by the Tender Opening Committee on **13.01.2023** at 10.35 hrs.

The Institute reserves the right to accept or reject any or all the offer including the lowest without assigning any reason.

12. GENERAL TERMS & CONDITIONS

- a) The successful vendor should setup the centralized administration module on the server/VM at the data centre of IIM Tiruchirappalli. Hardware and operating system (Windows 2016 Server) will be provided by IIM Tiruchirappalli.
- b) The successful vendor is responsible for rectifying the technical errors during the validity period of three years.

c) DELIVERY SCHEDULE

- i. *The existing License of the Antivirus software will be expiring on 25th March 2023. The successful bidder should complete the Activation / Renewal of Business /professional /corporate edition antivirus application for desktops and servers with effect from 26th March 2023.*
- ii. The vendor should ensure that the OEM sends the product licenses and login credentials directly to IIM Tiruchirappalli without marking any copy to the partner/vendor.
- iii. In addition to the partner support, the vendor should ensure that the OEM also provide direct support to IIM Tiruchirappalli officials to troubleshoot any technical issues, if needed.
- iv. The vendor is responsible for clearing the technical errors during the contract period of three years. The vendor should send an engineer at site for troubleshooting the activation issues at no additional cost, if any.
- v. In case, the firm fails to renew the required items within specified period, the purchase order as a whole may be terminated. Applicable penalties would be levied to the supplier/vendor. The decision of the competent authority in the matter of penalties would be final and binding.

d) PAYMENT TERMS

- i. No advance payment will be made in any case.
- ii. The contract will be for a period of three years and the payment will be released on yearly basis in advance.
- iii. Payment for the first year will be released after successful installation & activation along with upgrades to the latest available version for IIM Tiruchirappalli **within 25 days'** subject to submission of Invoice/Bill with all relevant documents like partner id, agreement number etc.

- iv. Payment for the second and third year will be released in advance after the successful renewal of the subscription. The same will be verified on the volume licensing Service center (dashboard).
- v. TDS and any other Government levies applicable on bills as per Government instructions/ notifications issued from time to time shall be applicable and deducted from Supplier/Vendor/Service Provider's bills.

e) PENALTY CLAUSE

Deficiency/delay in Supply/activation of the support and licenses will be construed as lapses on the part of the vendor. Such lapses due to vendor will be viewed seriously and penalties will be imposed on the vendor in case of any delay in providing the required materials as covered by this Tender within the stipulated date and timings. IIM Tiruchirappalli reserves the right to impose the penalty and the quantum of the penalty will be decided in individual cases and decision of the competent authority at IIM Tiruchirappalli, shall be final and binding.

f) CONDITIONAL BIDS

Conditional bids or Bids based on the process / basic schemes other than mentioned and / or not conforming to the technical specifications / requirements of the Bidding documents will not be considered.

g) PERFORMANCE SECURITY

- i. The successful bidder will be required to remit an interest free Performance Security Deposit of 3% of the Purchase Order value through online transfer to IIM Tiruchirappalli Bank Account, within Seven working days from receipt of the Purchase order. The security deposit will remain with the Institute during the contract period and it will be refunded after 60 days of successful completion of the contract after adjusting applicable deductions, if any.
- ii. Performance Security will be refunded to the Service Provider, after the Service Provider duly performs and completes the contract/warranty period in all respect.
- iii. Performance Security will be forfeited if the Service Provide fails to perform/abide by any of the terms or conditions of the contract.
- iv. In case, the Service Provider fails to provide the required services within specified delivery period, the same services will be obtained from open market and the difference of cost, if any, will be recovered from Performance Security or from pending bill(s) of the defaulting firm or from both in case the recoverable amount exceeds the amount of Performance Security.

h) Additional Quantity Clause:

IIM Tiruchirappalli shall exercise an option to procure an additional Quantity of the Antivirus Licenses during the entire contract period in addition to the quantity initially mentioned in the tender in accordance with the same rate, terms & conditions of the tender. It will be entirely at the discretion of the Buyer (IIMT) to exercise this option or not.

i) VALIDITY OF BIDS AND RATES

- i. All the quoted rates would be valid until completion of the contract. No escalation of price whatsoever would be allowed during the currency of the contract, including extended period if any.
 - ii. The quote shall remain valid and open for acceptance for a period of 90 days from the date of opening of bid.
- j) Canvassing in connection with the tenders is strictly prohibited and tenders submitted by the tenderers who resort to canvassing will be liable to rejection. Any bribe, commission or advantage offered or promised by or on behalf of the tenderer to any officer or staff of IIM Tiruchirappalli shall block his/ her tender from being considered. Canvassing on the part or on behalf of the tenderer will also make his tender liable to rejection.**
- k) Authority of person signing document:** A person signing the tender application or any documents forming part of the contract on behalf of another shall be deemed to warranty that he/she has authority to bind such other and if, on enquiry, it appears that the person so signing had no authority to do so, the IIM Tiruchirappalli may without prejudice to other Civil and criminal remedies cancel contract and held the signatory liable for all cost and damages.
- l) In respect of supply to IIM Tiruchirappalli, the vendor shall be liable for depositing all taxes, levies, cess, etc. to the concerned tax collection authorities from time to time as per existing rules and regulations on the matter.**
- m) Arbitration:** In case of any unreconciled disputes between the parties IIM Tiruchirappalli and the agency/firm to whom the contract had been awarded, arising out of any of the terms of the Tender document, the dispute shall be referred to a single Arbitrator mutually agreed, as per Arbitration and Reconciliation Act 1996, in Tiruchirappalli jurisdiction. The decision of the Arbitrator shall be final and binding on the both parties. The language of the arbitration shall be English. The Place and seat of arbitration shall be in Tiruchirappalli.
- n) Jurisdiction:** All disputes arising out of this contract shall be subjected to the jurisdiction of Madurai Bench of Madras High Court.
- o) Force Majeure:**
- i. Should any force majeure circumstances arise, each of the contracting parties be excused for the non-fulfillment or for the delayed fulfillment of any of its contractual obligations, if the affected party within 15 days of its occurrence informs in a written form the other party.
 - ii. Force Majeure shall mean fire, flood, natural disaster, or other acts such as war, turmoil, sabotage, explosions, epidemics, quarantine restriction, strikes, and lockouts i.e. beyond the control of either party.
