1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

The following documents (S. No 1- 3) must be submitted along with the bid document; otherwise, the bid submitted by the bidder shall be rejected:

- Manufacturer's Authorization Form (MAF)** from the OEM, clearly indicating that the bidder is authorized to sell and provide the required services for Outdoor Access Points and Access Switches as mentioned in this bid document. Bids without the Manufacturer's Authorization Form (MAF) will not be considered.
- Self-Declaration** for the compatibility of the proposed products with our existing Ruckus Controller Smart Zone 100.
- Data Sheet** of the proposed Access Points and Access Switches must be submitted.
- A Pre-Bid Meeting with the intending bidders will be conducted in person/virtual mode at IIM Tiruchirappalli, Trichy - 620024 on 25.02.2025 at 11.00 Hrs. to clarify doubts that shall arise before submitting the bids. The bidders need to send the e-mail request to purchase@iimtrichy.ac.in, before 11.00 Hrs., on 24.02.2025 for attending the Pre-bid meeting. The Bidders are requested to mail their doubts/questions to purchase@iimtrichy.ac.in, prior to the pre-bid meeting i.e. by 11.00 Hrs., 24.02.2025 to enable us to clarify the doubts in the pre-bid meeting itself.

5. Price Bid Details:

The quantities mentioned in the Price Bid for the CAT 6 Cables for 7 Boxes (i.e., 2,135 Meters) are inclusive of charges for the supply and laying of 1" PVC Pipes with necessary bolts, clamps, screws, and joints. These quantities shall be increased or decreased depending upon the requirements of the Institute. The cables and conduits will be billed against actuals.

The successful (L1) bidder will be required to submit a detailed price split-up for the CAT 6 Cable category after the opening of the price bid through price justification in the following format:

The total amount should exactly match the rate quoted by the bidder for the CAT 6 Cable for Indoor Use (Q 2), and the same shall be used for the calculation of labor charges as mentioned in Serial Number 2 of the above table.

6. Repeat Order Clause:

IIM Tiruchirappalli may place a repeat order for the same quantity of items or less, as per the rate quoted by the successful bidder (L1), within six months from the date of supply or successful completion of the work. The repeat order will be subject to the same terms and conditions of the tender. In extraordinary circumstances, a repeat order may be placed within one year. The decision to place a repeat order will be entirely at the discretion of the buyer (IIM Tiruchirappalli).

7. Performance Security Details:

The successful Bidder will be required to remit an interest free Performance Security Deposit of 3% of the GeM Contract Order value through online transfer to IIM Tiruchirappalli Bank Account, within ten working days from the generation of GeM Order. The Security Deposit will remain with the Institute until the completion of the Support period of Five Years and it will be refunded after adjusting applicable deductions, if any. Performance Security will be forfeited if the vendor fails to perform/abide by any of the terms or conditions of the contract. In case, the Vendor fails to provide the required services as covered by this bid document within a specified delivery period, the same items will be obtained from the open market, and the difference of cost, if any, will be recovered from the Performance Security or from the pending bill(s) of the defaulting firm or from the vendor if the recoverable amount exceeds the Performance Security.

8. While making payment to the Service Provider, TDS and other statutory deductions will be effected by the Institute.
9. The Income Tax (TDS) shall be deducted at prevailing rate from the bills, as amended from time to time in accordance with the provisions of Income Tax Department, and the relevant certificate to this effect shall be issued by IIM Tiruchirappalli to the Agency.

1. The Bidder is advised to visit and examine the installation site and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder.

Bidder must email purchase@iimtrichy.ac.in for site visit approval.

2. The Bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.

3. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary

13. Generic

16. OEM

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

17. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

18. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

19. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

20. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

21. Warranty

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

22. Warranty

Warranty period of the supplied products shall be 5 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at

consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

23. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 3 days time limit.
