- 4. **Work Schedule:** within **15** days from the date of receipt of the Work Order. If the agency/firm fails to complete the work within the stipulated period, the institute has the right to cancel the Work Order or take appropriate actions as deemed necessary.
- 5. Scope of Work:
 - Supply and laying of double-charged polished vitrified tiles in different areas and floors as per the specifications mentioned in the tender.
