	Whether Wardrobe shelves should be made of welded or riveted procedure?	Wardrobe shelves should be made of welded procedure in neat manner with excellent finishing.
	What is the width of wardrobe?	The inner width of the Wardrobe should be 18 Inches.
	Whether Wardrobes should be made of painted or powder coated?	All wardrobes should be made of powder coated.
Page No. 14 Point: 03	Whether three years warranty is mandatory for the Chairs?	Yes. <i>Three year warranty is mandatory</i> for all the items mentioned in the Tender including the Chairs.
BoQ of Price Bid : Sl. No. 03	Supply of Chairs: Whether BIFMA certificate is mandatory for chairs /finished product or the bidder can submit the certificate from the material supplier?	It is mandatory for the Bidder to submit the BIFMA certificate for the finished product of the revolving Chairs. The BIFMA certificate for the chair materials is not acceptable.
	If BIFMA certificate is unable to get it due to lockdown, can we produce the certificate during supply of the Chairs.	The bidder should submit an undertaking in their letterhead along with the technical bid to produce the BIFMA certificate at the time of supply of the Chairs subject to becoming a successful bidder. If the BIFMA Certificate is not produced at the time of supply, the purchase order will be cancelled and the items will be returned.

BoQ of the Price Bid: Sl. No. 01	Supplying of MS powder Coated cot: Whether 15mm x 15mm intermediate plate for the cot is sufficient.	30 mm x 30 mm intermediate stiffener should be provided for the Cot.

The evaluation for each items is independent and the purchase order will be issued to the successful bidder based on the Item wise L1.
