1.	-	How can bidders obtain the requirements and other relevant information about IIM Trichy?	Bidders are encouraged to visit the IIM Tiruchirappalli campus and engage with relevant stakeholders to better understand the institute's requirements prior to submitting their bids. However, once the work order is awarded, the successful bidder will be required to make multiple visits to the campus to interact with stakeholders and gain a thorough understanding of the institute's needs.
2.	-	As per tender conditions, the successful bidder should complete the stipulated work within 90 days from the date of receipt of the Work Order. Can that be relaxed?	Revised Delivery deadline: 110 days (from the date of WO). A buffer/grace period of 15 additional days will be provided in case of any delays from the institute's side in scheduling meetings or making decisions on sub-aspects.
3.	Pg. No. 14 - 16 (RFP Evaluation Process)	Does the presentation on its own carry a score when calculating for technical evaluation?	Sl. No. 1 to 3 of the Technical Evaluation Parameters will be assessed based on document verification, while items under Sl. No. 4 to 6 will be evaluated based on the presentation made to the Expert Committee.
4.	Pg. No. 14 - 16 (RFP Evaluation Process)	How the technical evaluation scores will be awarded?	The combined score is based on both the documents submitted and the presentation made by the bidder to the Expert Committee. The price bids will only be considered for opening if the bidder
