- 3. Bidder should take into account the Corrigendum/Addendum published on the IIM Tiruchirappalli website on the tender page from time to time before submitting the bids.
- 4. **Delivery Schedule:** within **15** days from the date of receipt of the Work Order. If the agency/firm fails to complete the work within the stipulated period, the institute has the right to cancel the Work Order or take appropriate actions as deemed necessary.

## 5. Scope of Work:

#### **New Gas Line Installation:**

**Laying of Pipeline:** The bidder shall lay 100 feet of the new gas pipeline from the existing gas source to the designated chapatti machine location. The installation must ensure proper alignment, clamps support etc.

#### **Modification of Existing Pipeline:**

Pipeline Removal and Relocation: The bidder shall carefully remove the existing pipeline as directed by the Engineer-in-Charge at site. The bidder shall reinstall the removed pipeline at the new location as directed by the Engineer-in-Charge

## **Connection and Testing:**

**Secure Connection:** The bidder shall securely connect the newly installed pipeline to the existing gas system, ensuring compatibility and integrity of the connection.

**Pressure Testing and Leak Detection:** The bidder shall perform pressure testing and leak detection on the entire gas pipeline system to verify and confirm the integrity and safety of the installation. Any leaks or defects identified must be rectified promptly.

**Safety Equipment:** The safety equipment's required to ensure safety protocols are under agencies scope such as gas detectors, shut-off valves, and pressure regulators.

## **Documentation and Handover:**

**Handover:** After successful completion of the work and confirming all the safety tests in presence of the estate office, the bidder shall hand over the system to the Engineer-in-Charge, along with all relevant documentation.

- 6. The Bidder (s) should have been registered with the Goods and Services Tax Council for the purpose of Goods & Service Tax (GST). A copy of the GST registration certificate has to be submitted with the tender document. A copy of the GST Registration Certificate, PAN, and Bank account details should be submitted along with the Bid. The names appearing on all these documents and the tender document should be the same or linked.
- 7. **Additional Quantity Clause:** IIM Tiruchirappalli shall exercise an option to procure additional Quantity of the items in addition to the quantity initially mentioned in the tender at the same rate, terms & conditions of the tender. It will be entirely at the discretion of the Buyer (IIMT) to exercise this option or not.
- 8. **Repeat Order Clause:** IIM Tiruchirappalli shall place the repeat order for the same quantity of the items or less as per the rate quoted by the successful Bidder (L1) within six months from the date of supply/ successful commissioning/installation of the work with the same terms & conditions of the tender. In extraordinary circumstances, a repeat order shall be placed within 01 (one) year. It would be entirely at the discretion of the buyer (IIMT) to place the repeat order or not.

- 10. The bidder should quote the rate for all the items failing which the tender will not be considered for further evaluation.
- 11. The bidder should submit the tender duly signed and stamped on all the pages.
- 12. IIMT reserves the right to change/ extend/ modify/ amend or delete any of the conditions, clause or items stated therein any or all provisions of this Tender document. Such revisions / amended/ corrigendum will be made available on the website of the IIMT Tender portal.

- 14. No telex/telegraphic/fax tenders will be accepted.
